Complaint Form

OVERVIEW

The CRS framework relies on three tiers of review: immediate action to protect the public interest, informal mediation by an Ombudsman, and if necessary binding arbitration by an Expert.

The Complaint Form below should be completed, signed and sent by email to crs@coccaregistry.org.

Fees

Lodging a complaint is free.

Amicable Complaint Resolution is free.

The applicable fee for referral to an Expert for binding arbitration is \$2500 USD.

Complaint Resolution Service: initial review

On receipt of a signed Compliant form, a preliminary review by CoCCA will take place to determine if suspension of the domain(s) is required to protect the public interest.

Complaint Resolution Service: amicable complaint resolution

CoCCA will refer the complaint to the Ombudsman to conduct a period of mediation to reach an amicable resolution of the complaint. All correspondence and communication during mediation is confidential and handled only by the Ombudsman.

If amicable resolution is not possible, and the Complainant desires to proceed further, the matter can sent to an Expert for binding arbitration.

Adjudication by an Expert

On receipt of applicable fees from the Complainant, CoCCA will appoint an Expert on a rotational basis from its list of Experts. The Expert will make a binding ruling on the Complaint on the basis of the Parties' submissions and the TLD Policy and Procedures.

On receipt of a Decision from the Expert, CoCCA will communicate the full text of the Decision to each Party via email and will implement the actions (if any) required by the Decision from the Expert.
